## RECREATIONAL NAVIGATION WITHOUT ANY LIMIT

Carried out by boats and pleasure ships, as defined by Article 3 of the Legislative Decree 18 July 2005 n.171, with staff embarked and engaged in rental activities.

With regard to the NAUTICA FROM DIPORTO, the equipment provided in Table A must be present on board only if the vessel meets all three of the following requirements:

- 1 recreational navigation with no limit
- 2 presence of maritime personnel boarded and registered in crew role
- 3 boat used in rental activities

For these vessels the checks will be carried out by the Maritime Authority together with the Maritime Health Authority and the health certificate will be issued by the Office of Maritime Health.
